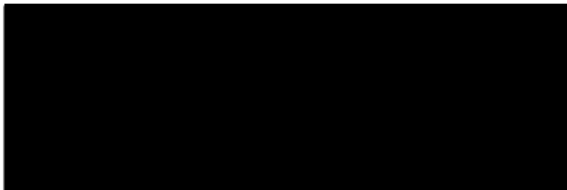
3. CONTRACTS

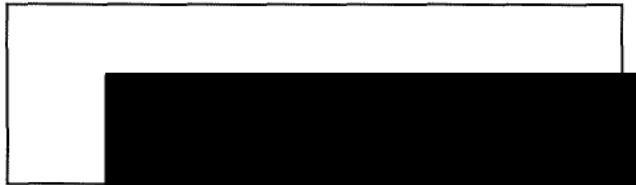
